Distributions are payable April 10, 2025 to shareholders on record as at March 31, 2025.

Since inception Class A shareholders have received a total of \$17.63 per share and Preferred shareholders have received a total of \$11.91 per share inclusive of this distribution, for a combined total of \$29.54.
