(The "Company") declares its regular monthly distribution of \$0.11335 for each Class A share (\$1.3602 annualized) and \$0.05625 for each Preferred share (\$0.675 annually). Distributions are payable March 10, 2021 to shareholders on record as at February 26, 2021.

Since inception Class A shareholders have received a total of \$14.12 per share and Preferred shareholders have received a total of \$8.71 per share inclusive of this distribution, for a combined total of \$22.83.
