Monthly Dividend Declaration for Class A & Preferred Share

Toronto, Ontario - July 20, 2022 / Globe NewsWire: Prime Dividend Corp. (The "Company") declares its monthly distribution of \$0.07317 for each Class A share and \$0.05875 for each Preferred share. Distributions are payable August 10, 2022 to shareholders on record as at July 29, 2022.

Under the distribution policy announced on July 17, 2014, the monthly dividend payable on the Class A shares is determined by applying a 10.00% annualized rate on the volume weighted average market price (VWAP) of the Class A shares over the last 5 trading days of the preceding month. As a result, Class A shareholders of record on July 29, 2022 will receive a dividend of \$0.07317 per share based on the VWAP of \$8.78 payable on August 10, 2022. The yield will remain stable at 10.00% (based on the VWAP) under this distribution policy.

Preferred shareholders will receive prime plus 2.35% with a minimum rate of 5.00%.

Since inception Class A shareholders have received a total of \$12.71 per share and Preferred shareholders have received a total of \$8.97 per share inclusive of this distribution, for a combined total of \$21.68.
