Distributions are payable January 9, 2026 to shareholders on record as at December 31, 2025.

Since inception Class A shareholders have received a total of \$28.07 per share and Preferred shareholders have received a total of \$12.96 per share inclusive of this distribution, for a combined total of \$41.03.
